## **Conditions for Reproduction/Publication**

- Written permission to reproduce or publish photographic images must be secured from the New Mexico
  Museum of Art. Permission is granted for use <u>one time, one edition at the designated print run only</u>. All
  other rights, including those of further reproduction or publication, are reserved in full by the New Mexico
  Museum of Art. Possession of a Museum image does not constitute permission to use or publish it.
- 2. Requests for alterations or variations to the image such as cropping, overprinting or bleeding to edge of any reproduction must be made in writing to the New Mexico Museum of Art. Details must be identified as such.
- 3. Georgia O'Keeffe images may only be reproduced with the understanding that they will not be cropped or altered in anyway, bled to the edges, guttered, wrapped around the outside cover (if approved as a cover image) nor superimposed with any other images or printing. The image(s) must be surrounded by a white border of an appropriate size to aid the reproduced image(s) to stand out from all other elements of the design.
- 4. Frederick Hammersley images may only be reproduced with the understanding that they will not be cropped, overprinted / superimposed, bled off the page, disported or altered in terms of the proportions, without prior authorization, except to depict a detail. It is understood and agreed that any image shown in detail form will also be presented as a full, unamended image.
- 5. All efforts should be made to make photographic reproductions as faithful and accurate to the originals as possible. Before publication of any reproduction, the New Mexico Museum of Art reserves the right to require a proof for final approval.
- 6. The New Mexico Museum of Art requires and will furnish the exact citation (credit line) to accompany each reproduction.
- 7. The credit line as specified is **MANDATORY**.
  - i. With printed matter, it is preferred that the credit line appear on the same or facing page as the illustrations with other "Sources of Illustrations". Crediting of each individual item is necessary in all cases.
  - ii. With exhibitions, it is preferred the credit be shown within exhibition area.
- 8. Publisher shall furnish the New Mexico Museum of Art without charge two (2) copies of each publication or book in which reproduction appears.
- 9. Orders will not be processed until payment is received in full; the New Mexico Museum of Art is not responsible for foreign banking fees. The granting of rights is contingent upon payment of fees.
- 10. Checks must be made payable to the New Mexico Museum of Art. Credit cards cannot be accepted.
- 11. The New Mexico Museum of Art gives no exclusive rights to any publisher, author or photographer and assumes no responsibility for duplication of subjects by others.
- 12. It is the responsibility of the applicant to secure the rights to reproduce the requested images from the appropriate copyright holders.
- 13. In the event that any additional uses of the image(s), not currently listed on the front, are planned additional permission must be obtained in advance.
- 14. Web images must not exceed 600 pixels on the longest edge.
- 15. **FORCE MAJEURE** If the museum is unable to fulfill its obligation to provide the image(s) due to any casualty or unforeseeable cause beyond the control of New Mexico Museum of Art, including, without limitation, acts of God, fires, floods, epidemics, pandemics (such as COVID-19 Corona Virus), quarantine restrictions, terrorist acts, strikes, labor disputes, governmental shutdowns or closures, failure of public utilities, or severe weather, prevents occupancy and use, or either, of the New Mexico Museum of Art, as granted in this Agreement, the New Mexico Museum of Art is hereby released by author/publisher from any damage so caused thereby.
