### COLL 0053: Southwest Art History Conference (SWAHC) Collection

**History:** The Southwestern Art History Council is an educational non-profit whose mission is to advance the art history of the American Southwest by demonstrating its importance to the wider cultural context of the world's art history. Their first conference was held in 1986 by a small yet dedicated group of art historians, led by David Witt of the Harwood Museum. This group recognized the need to systemically study the previously overlooked fields of Southwestern art and cultural history, and the benefits of holding a conference where discussions on these topics could be held. Due to these art historians hard work, discourse on Southwestern art history flourished at their conferences.

Since 1986 SWAHC has grown significantly—in 1990 they were incorporated by the New Mexico State Government and in 1991 they became a tax-exempt organization with a national board. The board has 11 members who are responsible for selecting papers and organizing each year's conference, which continues to be held in Taos, NM. SWAHC conferences continue to serve as an opportunity for the active discussion of topics in Southwestern art history such as architecture, history, archaeology, sociology, anthropology, folklore, literature, and fine art. They also support other activities such as publications and exhibitions similarly invested in the advancement of art history education. Despite SWAHC's roots in New Mexico and the museum field, their conferences have had individuals in attendance from around the world and from a variety of professions—demonstrating the influence that SWAHC has had on Southwestern art history.

**Provenance:** Records of the Southwest Art History Conference (SWAHC) were donated to the New Mexico Museum of Art (NMMOA) by the SWAHC Board in 2010 or 2011. Records were produced and/or collected by the SWAHC and its board members. SWAHC continues to hold annual conferences and produce original records which are periodically added to the original collection. Ellen Zieselman, SWAHC Board Treasurer (2022) has facilitated the transfer of records to the archives at NMMOA.

**Scope and Content:** Consists of records made by SWAHC members and some records about SWAHC by outside parties. The bulk of the records are comprised of programs, abstracts, A/V recordings, and other materials that directly pertain to conference proceedings. Other records either relate to preparations made by board members for the conference or to the functions of the board. These sections include press, meeting activities, correspondence, and government forms. There are also photographs, negatives, and 35 mm slides included in the collection.
